BRIEF DESCRIPTION

Department of Commerce Organizes Field Visit on Legal Awareness On the 17th of March 2023, the Department faculty organized a field visit aimed at raising legal awareness among the students. This initiative was part of the department's commitment to providing a holistic education that not only equips students with business and economic knowledge but also empowers them with a deeper understanding of the legal aspects that govern the world of commerce. Objectives of the Field Visit:

- 4. **Improved Decision-Making**: Participants noted that their ability to make informed business decisions had improved. They were now more cautious about legal implications when strategizing for a business venture.
- 5. **Awareness of Ethical Business Practices**: The visit also instilled a sense of ethical responsibility. Students became more conscious of the need for ethical business practices and compliance with the law.
